## Diversity, Equity and Inclusion Highlight

As she ponders what is developmentally appropriate to teach about Martin Luther King, Jr. Day and other "peace heroes," educator Nadia Jaboneta reflects on her anti-bias teaching. "The children had big questions. They wanted to have real conversations and understand why things happen in our world. They asked about life, death, fairness, skin color, and race." Jaboneta is fueled by the hope that she "can be as prepared as possible and answer children in a way that is honest, is developmentally appropriate, respects their competence and point of view, helps them feel safe, and shows them their power to change the world."

## Mini-Grants to Support Healthier Lifestyles- Apply Now

We are thrilled to share an opportunity for center-based Delaware early childhood education (ECE) programs to receive funding through the Delaware Advancing Healthy Lifestyles Healthy ECE Mini-Grant Program! This program offers mini-grants of up to \$10,000 to support initiatives that foster healthier lifestyles for children through physical activity and nutrition-focused interventions. Eligible projects include programs, events, or policy changes that improve physical activity, nutrition, and overall health in your center-based ECE environment. Apply by January 31.

# **Quality Improvement Planning**

If you are working on a Quality Improvement Award application, be sure that you are referring to the most recent version of the **QIS Program and Policy Guide**. On page 2 of the guide, you will find a summary of the most recent updates made by the Delaware Department of Education.

### FY25 Quality Improvement (QI) Award Deadline

The next application deadline for the FY25 QI Award is March 15, 2025. Keep the important information below in mind if you would like to apply by March 15.

- You must be in contact with a QI Specialist AND have your first meeting scheduled by February 1st.
- This is the final opportunity to apply for a QI award in FY25.
- Your Quality Improvement Plan (QIP) must be co-created with a Quality Improvement Specialist to be eligible for the award.

- The program leader is responsible for connecting with their QI Specialist.
  - If you already have a QI Specialist, you can reach out to them directly.
  - If you do not yet have a QI Specialist, you must request support through the Delaware Early Care and Education portal. See the Program Portal Guide for information about how to use the portal and request QI Specialist support.
- **Developing a QIP is a multi-step process.** You will need to meet with your QI Specialist several times. To ensure your plan is developed and submitted on time, we encourage you to connect with your specialist as early as possible.
- QI Specialists are working with programs on a rolling, first-come, first-served basis.

QI Specialists are available to support programs in their quality improvement journey regardless of their intent to apply for a QI Award. #### **Quality Improvement Resource Highlight**

#### Important Update from the Delaware Department of Education (DDOE)

As shared at November's DECC meeting and at December's Provider Call, DEPDNow is no longer available as of January 1, 2025. Instead, three foundational courses can now be accessed through DIEEC using an online platform called Canvas.

Please note that each step below may require processing time. Creation of a Canvas account and access to courses on the Canvas platform are not instantaneous. Allow extra time for these steps when planning to enroll in the courses below.

#### 1. Request a Canvas Guest Account

- 2. Register for one of the three foundational courses.
  - Health & Safety Training for Child Care Professionals
  - Administration of Medication Certification
  - Maintaining Equity in Early Childhood: Suspension / Expulsion Prevention

Log in to Canvas and begin your course.
